What we collect

We may collect the following information:

- o name
- o contact information including email address
- o demographic information such as location, postcode, preferences and interests
- o other information relevant to customer surveys and/or offers

What we do with the information we gather

Security

We are committed to ensuring that your information is secure. In order to prevent unauthorised access or disclosure, we have put in place suitable physical, electronic and managerial procedures to safeguard and secure the information we collect online.

How we use cookies

A cookie is a small file which asks permission to be placed on your computer's hard drive.
